## MINUTES OF CHURCH COUNCIL APRIL 19, 2018

The regularly scheduled meeting of the Church Council was called to order at 7:01 p.m., on Thursday, April 19, 2018, by President David Ballah. Present were: President Ballah, Vice President Richard Sinnigen, Secretary David Martin, Financial Secretary Donna Buco, Chairperson of the Board of Stewardship Bill Oehlkers, Chairperson of the Board of Social Ministry Danlette Norris, and Pastor Leon Schultz. The meeting opened with a prayer offered by Pastor. Treasurer Dan Robinson joined the meeting at 7:15 p.m.

**Approval of Minutes.** A motion was made, seconded, and passed to approve the minutes of the Mar. 15, 2018, Church Council meeting as corrected.

**Treasurer's Report.** Dan Robinson presented the Treasurer's Report for the period Jan. 1 through Mar. 31, 2018. Total income during this period was \$56,786.51 and total disbursements were \$44,125.13, resulting in net ordinary income of \$12,661.38. Offerings are running approximately one Sunday ahead of the amount budgeted. The balance of Memorial Funds as of Mar. 31, 2018, is \$251,303.90.

**Pastor's Report.** Pastor reported that he baptized Amira Gormah Cole, the daughter of Audry Bryant and Joseph Cole, on April 8, 2018.

**Trustees.** David Martin reported that the Spring Cleanup will take place on Sat., April 21. Pastor said that Luis Wood of J & A General Contractor had cleaned and polished the parish hall floor. Luis also repaired the parish hall ceiling where it had been damaged by a water leak and fixed similar spots in the room to the left of the stage and along the Carter Street stairwell. Pastor reported that the heavy door between the kitchen and the parish hall had cracked and that it had been removed as a safety precaution

**Stewardship.** Bill Oehlkers reported that going forward the Board of Stewardship will focus on stewardship of our youth. An effort will be made to involve the youth to a greater degree in the life of the church. Among the areas to be looked at are music and youth activities.

**Social Ministry.** Danlette Norris reported that the Board of Social Ministry continues to reach out to sick and shut-in members. Board members take any unclaimed altar flowers to these persons. Danlette noted that the Prayer Breakfast which was held on Saturday, April 14, was very successful. Between 50 and 60 persons attended.

**Old Business. Child Protection Policy.** David Martin reported that Samantha Robinson had agreed to serve as Sunday School Superintendent. David will coordinate with her regarding implementation of the Child Protection Policy.

Nominating Committee. David Martin requested that the chairs of all boards advise the

**Nominating Committee.** David Martin requested that the chairs of all boards advise the Nominating Committee which of their members are willing to continue to serve on their respective boards. David noted that if the election is held on Sunday, May 27, the names of the candidates for officer and board positions must be announced not later than Sunday, May 13.

**Assignment of Alarm Responder.** David Martin said that he would confirm whether Julius Kolawole was interested in being the person who would respond to the church if the burglar alarm goes off after hours. If Julius is not interested, Danlette will take on this responsibility, and Rick Sinnigen will be the backup responder.

**Rental Policy Forum.** Bill Oehlkers reported that the second meeting concerning the church rental policy will be held this Sunday, April 22. The written recommendations concerning the policy that have been submitted will be discussed. Following the meeting, the Deacons will be informed of those recommendations for which there seems to be general support.

Cost of Trash Collection. Rick Sinnigen reported that he had contacted Rhode Island Waste Management and Patriot Disposal. Their prices were both in the area of \$375-\$380 per month which is significantly less than what we are presently paying. The Council agreed that Rick should send a letter to R.I. Waste Management to confirm what had been told to him verbally. If the price is confirmed, the Council agreed that we should switch our trash collection to R.I. Waste Management.

**New Business.** Parking Lot Problem. Pastor reported that there continues to be undesirable activity in our parking lot after dark, especially in the area near the dumpsters. It was agreed that David Martin should send a letter to the Providence Police asking them to check our lot during the hours of darkness. In addition, David will investigate two additional possible solutions: 1) erecting a solar floodlight to illuminate the area around the dumpsters, and 2) asking the owner of the parking lot directly opposite the Carter Street door if they would allow us to erect a lightpole on their property, connect it to their electrical supply, and reimburse them for the cost of the electricity.

There being no further business, a motion to adjourn was made, seconded, and passed. The meeting ended at 8:18 p.m. with recitation of The Lord's Prayer.
